## NEWSWEEK RAISES OBAMA TO GODHOOD

Newsweek editor Evan Thomas brought adulation over President Obama's Cairo speech to a whole new level on Friday, declaring on MSNBC: "**I mean in a way Obama's standing above the country, above – above the world, he's sort of God.**"<sup>1</sup>

Thomas, appearing on Hardball with Chris Matthews, (whose leg twitches when he comes into Obama's presence) was reacting to a preceding monologue in which Matthews praised Obama's speech: "I think the President's speech yesterday was the reason we Americans elected him. **It was grand. It was positive. Hopeful ... But what I liked about the President's speech in Cairo was that it showed a complete humility...**The question now is whether the President we elected and spoke for us so grandly yesterday can carry out the great

vision he gave us and to the world."

Matthews discussed Obama's upcoming speech marking the 65<sup>th</sup> anniversary of D-Day and compared it to that of Ronald Reagan. He then turned to Thomas and asked: "Reagan and World War II and the sense of us as the good guys in the world, how are we doing?" Thomas replied: "Well, we were the good guys in 1984, it felt that way. It hasn't felt that way in recent years. So Obama's had, really, a different task **We're seen too often as the bad guys.** And he – he has a very different job from – **Reagan was all about America,** and you talked about it. **Obama is 'we are above that now.'** **We're not just parochial,** (close-minded) **we're not just chauvinistic,** (bigoted, prejudiced, opinionated) **we're not just provincial** (local, regional, central)."<sup>2</sup>

Thomas elaborated on Obama as God, patronizingly explaining: "He's going to bring all different sides together ... Obama is trying to sort of tamper everything down. He doesn't even use the word terror. He uses extremism. He's all about let us reason together ... He's the teacher. He is going to say, 'now, children, stop fighting and quarreling with each other.' And he has a kind of a moral authority that he – he can – he can do that." In response, Matthews wondered: "If there's a world election between him and Osama Bin Laden, he's running a good campaign." Thomas agreed: "Yes, he is."<sup>3</sup>

**I, Bishop Ron McRae am over the age of eighteen (18) and not a party to the within action. If called to do so, I could and would competently testify under oath as follows:**

**I am the Continental Bishop who oversees the Anabaptists Churches in North America. I am also the Presiding Elder on the African Presbytery, where we have numerous churches throughout Kenya, Uganda, Tanzania, the Democratic Republic of the Congo and mission works to several other African nations. The African Presbytery is comprised of the national bishops of the various countries**

**we minister in and support, along with our statewide bishops from New York and Pennsylvania.**

**We actively visit and minister throughout these African countries, and do so extensively throughout all of Kenya these last three (3) years. in overseeing the establishment of our churches and presbytery to Kenya over the last two (2) years we have had personal dealings, continually, with many citizens of Kenya from every tribe and economic standing throughout the wonderful nation of Kenya, with whom the national interests in United States Senator Barack Hussein Obama is a very popular topic of discussion. The tribal cultures of the Kenyanese people have involved much turmoil during the national elections at the end of December 2007 and the beginning of 2008.**

**The much published violence that erupted over the presidential elections caught the world's attention. Myself and several American minister with our church were present during this time in Kenya, and the facts concerning this strife and the ensuing violence were well known, and of common knowledge throughout all of Kenya.**

**The opposition party that was responsible for all of the violence was from the minority Luo tribe, which is a Muslim tribe that supported Mr. Raila Odinga for president. Raila Odinga is a Marxist socialist who graduated from the East Germany Magdeburg University in 1970 on a scholarship from the East German government. He named his first born son after Fidel Castro. Raila Odinga spent six years in prison for his admitted involvement in the bloody coup attempt in 1982 to over take and assassinate Daniel Arap Moi, Kenya's President. Mr. Odinga has publicly admitted to being the leader of that coup in his 2006.**

**Mr. Odinga is the cousin of United States Senator Barack Obama. Mr. Obama is from the same Muslim tribe, the Luo Tribe, as Mr. Odinga. Senator Obama visited Kenya in August of 2006 and campaigned extensively for his cousin, Mr. Odinga, which gave Odinga a tremendous boost. During Senator Obama's campaign stops on behalf of his cousin Odinga, the Senator made numerous claims against the democratic government of Kenya and Kenya's President Mwai Kibaki, claiming they were corrupt, stating often, that Kenya was "ready for change", just as he has campaigned here in the United States during the Presidential election. It has been common knowledge throughout Kenya that Senator Obama sent his foreign policy advisor, Mr. Mark Lippert, to Kenya at least three times to advise Mr.Odinga on his campaign strategies. See Mark Hyman's Washington Times article published October, 12, 2008, attached as Exhibit "I". Moreover, everyone in Kenya is well aware that Senator Obama donated over one million American dollars (\$1,000,000) to his cousin's, Mr. Odinga's campaign, which is documented in the Kenyan Political Party, for Mr. Odinga. Orange Democratic Movement (hereinafter "ODM") along with extensive funds from other Muslim supporters including but not limited to the Muslim son of Muammar Gadhafi, the dictator of Libyan's Muslim government. These issues are common knowledge throughout Kenya, and the information is publicly document across the internet.**

**It is detailed in Odinga's financial reports and strategies ODM Internal Memo documents, attached as Exhibit "2♦♦", which are public records, that a significant portion of Senator Obama's financial contributions (made through an organization identified as Friends of Senator Barack Obama) were used to help finance both the signed Muslim Memorandum of Understanding as well as the planned violence, murders and bloodshed that occurred in December of 2007. Within the ODM Internal**

**Memo attached as Exhibit "2♦♦", the funds donated by Mr. Obama through "Friends of Senator Barack Obama" were to be used for "Violence as a last result♦cto discourage voter participation in hostile areas..use ODM agents on the ground to engineer ethnic tensions in target areas♦csupport Kapondi's forces in Mt. Eglori", and to do as during "Mid-December". Unfortunately, the exact violence described in these reports was carried out and occurred at the beginning of the second week of December 2007.**

**Additionally, it is common knowledge throughout both the Christian and Muslim communities in Kenya, that contrary to news media propaganda here in the United States, US Senator Barack Obama is a Muslim and not a Christian, and that he was born in Mombasa, Kenya and not in the State of Hawaii as falsely purported by the Obama campaign for presidency of the United States. Mr. Obama's cousin ran his failed campaign for the Kenyan presidency in the identical fashion of Senator Obama's American campaign strategy, and that being to join a nominal Christian Church in order to publicly profess to be a Christian, while maintaining their actual Muslim beliefs, in order to sway public opinion away from the actual fact of his strong Muslim beliefs, family and goals. It is a known fact that membership in the United Church of Christ in Chicago, where Barack Obama was a member, does not require muslims to renounce their Islamic faith in order to join the UCC church. Throughout Kenya it is and was well publicized in the media that a Memorandum of Understanding agreement, attached as Exhibit "3♦♦", between Raila Odinga and Shiek Abdullahi Abdi, chairman of the National Muslim Leaders Forum, was signed by Odinga in August 29, 2007 in which Raila Odinga promised if elected to implement drastic changes including but not limited to the following:**

- \* Recognize "Islam as the only true religion"**
- \* "Islamic leaders would have an oversight rule to monitor activities of ALL other religions (emphasis in the original)**
- \* Installation of Shariah courts in every jurisdiction to implement Islamic law**
- \* Implement a ban on Christian preaching**

**Because of the seriousness of all of the above, as a Christian and a citizen of the United States, this preacher could no longer sit idly by knowing these things and continue to minister in both Kenya and the United States. As the presiding bishop over the Continental Presbytery of Africa, I authorized representatives within our church to locate and interview Ms. Sarah Hussein Obama, the actual grandmother of US Senator Barack Obama. Ms. Sarah Obama lives in the Alego-Kogello, approximately 37 miles from Kisumu, where the Anabaptists have a congregation, and where this preacher has preached several times prior to the December elections in 2007, and prior to the planned violence from the Odinga supporters, which erupted.**

**With Senator Obama being born in Kenya and not in the United States, he is not a "natural born" citizen and it prohibits him from being eligible to run for and/or serve as President of the United**

States. Since Senator Obama's birth was reportedly in 1961, birth records may or may not be available, so I felt it very important to obtain the testimony of his grandmother as a first hand witness, since it is commonly known throughout Kenya, and especially around the Kisumu area, that Sarah Obama was present when Barack Obama, Jr. was born in Kenya.

Accordingly, on Thursday, October 16, 2008 Reverend Kweli Shuhudia (actual name temporarily withheld to protect his life), an evangelist with our ministries traveled to Kogello and located Ms. Sarah Obama at her home, see the attached email attached as Exhibit "4♦♦. Mr. Shuhudu is a very intelligent and educated citizen of Africa, a former teacher and respected evangelist throughout Africa. Mr. Shuhudia acts as our official translator when we are in Africa, and is fluent in both Swahili and English. Mr. Shuhudu met and interviewed Ms. Sarah Obama at length on October 16th during which interview, he called me on my mobile number, see my phone record attached as Exhibit "6♦♦. Mr. Shuhudia called me first on October 16th at 10:33 a.m. and advised that he was with Sarah Hussein Obama and that she wanted to speak with me, but the connection was lost. He called me right back at 10:35 a.m. and he informed me that there were several hundred people present, celebrating Obama's success. I questioned him about the format of the phone call and conversation with Ms. Obama, and then informed him that I would call him right back, so it would not cost him international charges for the call. I called him back at 10:40 a.m. and public music and voices could be heard that were gathered around Kweli Shuhudia. I then spoke with him and requested that they utilize the speaker phone so everyone could hear.

The speaker phone with its open microphone was utilized with Mr. Shuhudia, Mr. Vatalis Alec Ogombe the Kogelo Community chairman assisting in the translation work and Ms. Sarah Hussein, along with several hundred people including policemen present and listening in the open conversation between the four of us for approximately 15 minutes. Mr. VO is also the step grandson of Ms. Obama and the cousin of Barack Obama. A third unknown party can be heard periodically interjecting both Swahili and English words in the public discussion and conversation between the four of us. At times, the room noise from other peoples' voices makes some of the Swahili difficult to hear, and towards the end of the conversation several men's voices are heard that are not identified. As I talked to and question Ms. Obama publicly over the open microphone of Mr. S's speaker phone, they would translate what I said to her in Swahili publicly, and then they would translate her Swahili responses to me publicly in English. Ms. Obama can fluently speak Swahili in her native dialect, but cannot read or write. In the ensuing public conversation, I asked Ms. Obama specifically, "Were you present when your grandson Barack Obama was born in Kenya?" this was asked to her in translation twice, and both times she specifically replied, "Yes! Yes she was! She was present when Obama was born." Though, some few younger relatives, including Mr. Ogombe, have obviously been versed to counter such facts with the common purported information from the American news media that Obama was born in Hawaii, Ms. Sarah Hussein Obama was very adamant that her grandson, Senator Barack Hussein Obama, was born in Kenya, and that she was present and witnessed his birth in Kenya, not the United States. When Mr. Ogombe attempted to counter Sarah Obama's clear responses to the question, verifying the birth of Senator Barack Obama in Kenya, I asked Mr. Ogombe, how she could be present at Barack Obama's birth if the Senator was born in Hawaii, but Ogombe would not answer the question, instead he repeatedly tried to insert that, "No, No, No, He was born in the United States!" 

Mbijiwe Mwenda says we are being naive to ignore Barack Obama's ties to a dangerous Kenyan politician.

Mbijiwe Mwenda is a voice crying in the wilderness—from the other side of the world.<sup>11</sup>

The Kenyan pastor, founder of Glory Cathedral Church in Nairobi, does not have a voice on CNN or Fox News. But he has been warning Christians during a recent visit to the United States that more is at stake in the 2008 election than anyone supposed.

lose the America we have known in the past—the America that has been a hope for the world.”  
“Democratic presidential challenger Barack Obama has a cozy relationship with Raila Odinga, an avowed Marxist politician who now serves as Kenya’s prime minister.”

Mwenda’s main concern: That Democratic presidential challenger Barack Obama has a cozy relationship with Raila Odinga, an avowed Marxist politician who now serves as Kenya’s prime minister. Obama, who made taxpayer-funded visits to Kenya in 2004, 2005 and 2006, campaigned for Odinga in 2006.

During public appearances in Kenya, Odinga introduced Obama as his cousin. But later a family member denied that claim, saying that Odinga and Obama’s father, Barack Obama Sr., simply came from the same village. Both Obama Sr. and Odinga are from the Luo tribe, Kenya’s third largest.

When Odinga ran for president of Kenya last year and lost by a slim margin, tribal violence erupted amid claims of voter fraud. About 150,000 people died (many were killed in machete attacks), hundreds of churches were burned and 600,000 villagers were displaced. The international community had to broker a peace deal, allowing Odinga to serve as prime minister while his opponent, Mwai Kibaki, was named president.

Today, Odinga hopes that Obama will win the White House on Nov. 4 to boost support for his bid to become president of Kenya in 2012.

Pastor Mwenda says he is amazed that Americans don’t seem concerned that Obama is tied to Odinga. He rattled off a list of facts that Charisma has verified:

- Odinga was trained in communist ideology in Europe and holds Marxist views. “He even named his son Fidel Castro,” Mwenda says.
- He has obvious ties to Muslim interests and even received funding for his presidential campaign from Libya. Although he officially claims to be an Anglican, Mwenda says, “[Odinga] has been very sympathetic to Muslims and some say he is a Muslim secretly.”
- Odinga fits in nicely with Arab leaders’ plans for Africa. When they convened in Nigeria in 2001, they released a statement indicating that Kenya is to play a key role in spreading Islam throughout southern Africa. Says Mwenda: “Odinga is a dangerous man. A dictator.”
- Odinga has promised to enact Sharia law in “Muslim declared regions” of Kenya—meaning that pork would be outlawed, women could not drive and crimes would be punished according to Islamic tradition.

So why did Obama campaign for Odinga? Independent journalists around the world have been asking that question since 2006. Paula Abeles of African Press International wrote in August: “Clearly Obama campaigned for someone who is corrupt, ruthless and has financial ties to terrorists. ... Senator Obama’s actions—intentional or not—were in direct conflict with the efforts and interests of U.S. national security.”

Many Kenyans are proud that a son of Kenya has a shot at the White House. But Kenya’s evangelical Christians are less enthusiastic. Like Mwenda, many of them are also troubled that Obama’s paternal grandmother has publicly stated that she sacrifices chickens and pours libations daily when praying for Obama to win the election. “She has been doing this since the [Democratic] primaries,” Mwenda says.

“Something is about to go wrong in your country,” Mwenda warned me.

I know many people who read my column will assume I am only writing it to boost John McCain's chances at the polls next week. Some of my critics have also assumed that I must have racist tendencies if I am not voting for Barack Obama.

They can assume what they want, but the truth is that I have made eight trips to Africa in the last seven years and it is my second home. I will return there in early 2009. If my situation allowed it I would move there permanently—I love the people, the culture and what the Holy Spirit is doing all over that beautiful continent.

This week I did my own informal poll of African church leaders in Nigeria and Kenya. What I found was that none of them support Obama. Like many American Christians, they are staunchly pro-life, they defend traditional marriage and they certainly do not support politicians who don't take the threat of militant Islam seriously.

They have seen enough torched churches and amputated arms to know better. They have seen Christian children thrown into the bottom of wells to die. They have seen Shariah law cast a dark pall over whole regions. They have watched as Middle Eastern governments pour millions of dollars into their local economies to build mosques and infrastructure and to buy votes.<sup>12</sup>

I asked Pastor Mwenda how American Christians should pray in light of this sobering information. He told me: "I am praying that Obama does not win the White House. It is never too late for God. We can turn the tide. We need to pray: 'Our Father, Who art in heaven, Thy will be done on earth as it is in heaven.' We must not allow anything in this nation that is not in His will."<sup>13</sup>

(Washington, DC – 07/02/2009) - Philip J. Berg, Esquire, the first Attorney who filed suit against Barack H. The Code of Federal Regulations (CFR), 5 CFR § 2635, et seq. and 5 CFR § 2640, et seq. governs Governmental Employees, including U.S. Attorney General Eric Holder and his staff.

5 CFR § 2635.101 states in pertinent part, “(a) *Public service is a public trust*. Each employee has a responsibility to the United States Government and its citizens to place loyalty to the Constitution, laws and ethical principles above private gain.

In addition to the standards of ethical conduct set forth in the Code of Federal Regulations, there are Conflict-of-Interest statutes that prohibit certain conduct. Criminal Conflict-of-Interest statutes of general applicability to all employees, 18 U.S.C. §§ 201, 203, 205, 208, and 209, are summarized in the appropriate subparts located in these chapters and must be taken into consideration in determining whether conduct is proper.

As to the restrictions on Conflicts-of-Interest during government service, only Section 208 is illuminated by formal regulations, which are found in the Code of Federal Regulations (CFR).

5 CFR. § 2640.103 “Prohibition” states:

“(a) *Statutory prohibition*. Unless permitted by 18 U.S.C. 208(b) (1)–(4), an employee is prohibited by 18 U.S.C. 208(a) from participating personally and substantially in an official capacity in any particular matter in which, to his knowledge, he or any other person specified in the statute has a financial interest, if the particular matter will have a direct and

predictable effect on that interest. The restrictions of 18 U.S.C. 208 are described more fully in 5 CFR 2635.401 and 2635.402.

Berg stated, "U.S. Attorney General Eric Holder has a financial interest as does his staff as they draw their income from the Government who is over-seen by Barry Soetoro a/k/a Barack H. Obama".

"Eric Holder joined President Obama's presidential campaign as senior legal advisor and also served as one of three [3] members on Obama's vice-presidential selection committee. In December 2008, then President-elect, Obama asked Eric Holder to serve in his cabinet as the U.S. Attorney General. Mr. Holder was appointed by President Obama and now serves as the United States Attorney General; is the head of the United States Department of Justice and United States Attorney General's Office. Eric Holder is paid by the United States Government and reports directly to President Obama. Eric Holder has a direct financial interest in that he draws a salary based on his position as United States Attorney General. This Conflict-of-Interest goes beyond financial. The United States Attorney General is the Chief Law enforcement officer of the Federal Government and represents the United States in legal matters and gives advice and opinions to the President of the United States".

Conflicts-of-Interest include but are not limited to a financial interest; a personal interest; improper business practices; etc. Berg continued, "It is clear U.S. Attorney General Eric Holder and the staff in which he supervises have a huge Conflict-of-Interest as they have financial interests as well as personal interests which limits them from doing their job as required pursuant to the United States Constitution and therefore, Attorney General Eric Holder should recuse himself and/or designate Relator Philip J. Berg to proceed.

Berg concluded, "I am not giving up and am continuing my legal fight to prove Obama is **not** constitutionally qualified/eligible to be President of the United States. I am proceeding for the 305 + million people in 'our' U.S.A., for 'our' forefathers and for the 1.5 million men and women that have died defending our Constitution in the many wars over the years and the 1.5 million men and women who were injured in those wars,"<sup>15</sup>





The Word says, 1 Corinthians 10:21, "*Ye cannot drink the cup of the Lord, and the cup of devils: ye cannot be partakers of the Lord's table, and of the table of devils.*" Once a person turns away from God, Satan is there ready to give them a counterfeit faith, false prophet, psychic, or false religious experience. Unfortunately, help is rare once the victim is engaged. The Scripture prophesied that occult activity would be increased in the latter days.

*"He appeared first to Mary Magdalene, out of whom He had cast seven devils."*

Mary of Magdala was *the victim of a fearful evil*. She was possessed by not one devil only, but seven. These dreadful inmates caused much pain and pollution to the poor frame in which they had found a lodging. Hers was a hopeless, horrible case. She could not help herself, neither could any human succour avail. But Jesus passed that way, and unsought, and probably even resisted by the poor demoniac, He uttered the word of power, and Mary of Magdala became *a trophy of the healing power of Jesus*. All the seven demons left her, left her never to return, forcibly ejected by the Lord of all. What a blessed deliverance! What a happy change! From delirium to delight, from despair to peace, from hell to heaven! Straightway she became *a constant follower of Jesus*, catching His every word, following His devious steps, sharing His toilsome life; and withal she became *His generous helper*, first among that band of healed and grateful women who ministered unto Him of their substance. When Jesus was lifted up in crucifixion, Mary remained *the sharer of His shame*: we find her first beholding from afar, and then drawing near to the foot of the cross. She could not die on the cross with Jesus, but she stood as near it as she could, and when His blessed body was taken down, she watched to see how and where it was laid. She was *the faithful and watchful believer*, last at the sepulchre where Jesus slept, first at the grave whence He arose. Her holy fidelity made her *a favoured beholder of her beloved Rabboni*, who deigned to call her by her name, and to make her *His messenger of good news* to the trembling disciples and Peter. Thus grace found her a maniac and made her a minister,
